# Federal Ferry Grant/Loan Programs

## Federal Transit Administration (FTA)



- ✤ <u>Passenger Ferry Grant Program</u>
  - Competitive
  - Funding Levels/Sources:
    - Authorized at \$30 million per year out of the Highway Trust Fund plus any additional funding under the Transit Improvement Grant (TIG) Account appropriated on an annual basis
      - \$6.5 million in additional FY22 THUD Appropriations
      - \$15 million in additional FY23 THUD Appropriations
- Ferry Service for Rural Communities Program (IIJA Section 71103)
  - Competitive
  - Funding Levels/Sources:
    - Advanced Appropriations: \$200 million per year through 2026
    - Additional authorized funding per year (through 2026): up to \$200 million per year
      - \$12.965 million in FY22 THUD Appropriations
      - \$17.5 million in FY23 THUD Appropriations
- Electric or Low-Emitting Ferry Pilot Program (IIJA Section 71102)
  - Competitive
  - Funding Levels/Sources:
    - Advanced Appropriations: \$50 million per year through 2026
    - Additional authorized funding per year (through 2026): \$50 million per year
      - \$0 in FY22 THUD Appropriations
      - \$0 in FY23 THUD Appropriations

## Low or Zero-Emission Ferries Set-Aside

- Competitive
- Funding Levels/Sources:
  - No set amount, funded as a set-aside within the Passenger Ferry Grant program TIG funding annually

- \$3.25 million set aside in FY22 THUD Appropriations
- \$5 million set aside in FY23 THUD Appropriations

## Federal Highway Administration (FHWA)

#### ✤ Ferry Boat Program

- Formula
- Funding Levels/Sources:
  - Dedicated ferry funding is authorized from the Highway Trust Fund for FHWA's Ferry Boat Program. Funding for this program in the IIJA totaled \$912 million, an average of \$182 million per year.

### Loan Programs

- <u>TIFIA</u> Direct loans, loan guarantees, and standby lines of credit to finance surface transportation projects of national and regional significance.
- <u>Title XI</u> Long-term debt repayment guarantees for U.S. shipowners to obtain new vessels from U. S. shipyards cost effectively. Assists U.S. shipyards with modernizing their facilities for building and repairing vessels.
